

Reliable Parts Toolkit Sweepstakes Terms and Conditions DRAFT

1. **Eligibility:** Open only to legal U.S. residents and is void where prohibited by law. Employees of Reliable Parts, their respective affiliates, subsidiaries, advertising and promotion agencies, suppliers and their immediate family members and/or those living in the same household of each are not eligible to participate. Subject to all applicable federal, state and local laws and regulations.
2. **Agreement to Rules:** By participating, you agree to be fully unconditionally bound by these Rules, and you represent and warrant that you meet the eligibility requirements set forth herein. In addition, you agree to accept the decisions of Reliable Parts, as final and binding as it relates to the content.
3. **Sweepstakes Period:** Monthly entries must be received by the last weekday of the month, beginning on June 30, 2016. The final monthly entry must be received by December 30, 2016, 11:59pm central time.
4. **How to Enter:** The sweepstakes must be entered by submitting an entry form via email. The entry must fulfill all sweepstakes requirements, as specified, to be eligible to win a prize. If the selected winner cannot be contacted, is ineligible, fails to claim the prize within 15 days from the time award notification was sent, or fails to timely return a completed and executed declaration and releases as required, prize may be forfeited and an alternate winner selected.
7. **Rights Granted by you:** By entering this content you understand that Reliable Parts, anyone acting on behalf of Reliable Parts, or its respective licensees, successors and assigns will have the right, where permitted by law, without any further notice, review or consent to print, publish, broadcast, distribute, and use, worldwide in any media now known or hereafter in perpetuity and

throughout the World, your entry, including, without limitation, the entry and winner's name, portrait, picture, voice, likeness, image or statements about the sweepstakes, and biographical information as news, publicity or information and for trade, advertising, public relations and promotional purposes without any further compensation.

8. Terms: Reliable Parts reserves the right, in its sole discretion to cancel, terminate, modify or suspend the sweepstakes should (in its sole discretion) a virus, bugs, non-authorized human intervention, fraud or other causes beyond its control corrupt or affect the administration, security, fairness or proper conduct of the sweepstakes. In such case, Reliable Parts may select the recipients from all eligible entries received prior to and/or after (if appropriate) the action taken by Reliable Parts. Reliable Parts reserves the right at its sole discretion to disqualify any individual who tampers or attempts to tamper with the entry process or the operation of the sweepstakes or website or violates these Terms & Conditions.

10. Disputes: This sweepstakes is governed by the laws of the United States and Texas, without respect to conflict of law doctrines.
